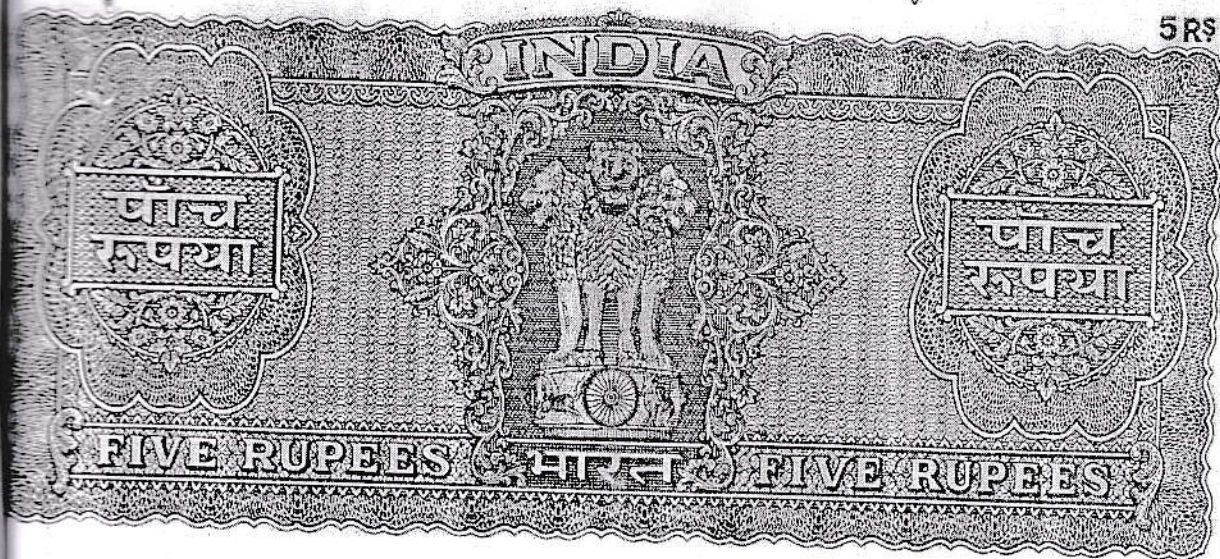

(iv) The Settlor has delivered the said aggregate sum of Rs.5,000/- (Rupees five thousand) to the Trustees to be held by them upon the Trusts and with the powers and subject to the provisions hereinafter declared;

1. That the Settlor in pursuance of the said desire and for the purpose of carrying out charitable objects herein-after mentioned and diverse other good causes and considerations moving unto him doth hereby declare that he has before the execution of these presents transferred and delivered and the Trustees do and each of them doth hereby confirm such transfer and delivery unto the Trustees of the said aggregate sum of Rupees Five Thousand and all his right title and interest therein.

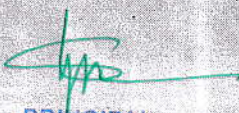
2. The Trustees shall stand possessed of and hold the said sum of Rupees Five Thousand and all the additions, donations and grantees of whatever kind or nature as may hereafter be received by the Trustees and any other investments for the time being representing the same and income thereof (and the said sum of Rupees Five Thousand and other investments thereof and hereinafter included in the term "Trust Property" which term is being intended to mean and include the said cash and any additions, donations and grantees of whatever kind and

nature as may hereafter be received by the Trustees and any other securities and investments of any kind whatsoever or any part thereof into which the same may be converted or varied from time to time upon the trusts and with and subject to the powers declarations conditions and provisions hereinafter expressed and contained of and concerning the same.

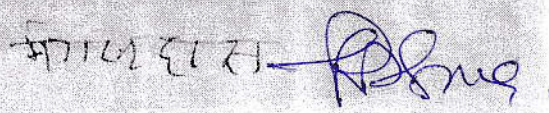
3.. The Trust shall be known as GURUJI PRANAMI MISSION TRUST with its Office at Pranami Mandir, Kalimpong, District Darjeeling (West Bengal).

4. The Trustees shall hold and stand possessed of the trust property upon the following trusts:-

- (a) To collect, get in and receive the interest dividends, rents, profits and other income of the Trust property from time to time as and when the same become due and payable, to pay out of the said interest, dividends, rents, profits and other income all outgoings payable in respect of the Trust property including all ground rent, rates, taxes, and cost of repairs of any immovable property forming a part of the Trust property, premium for insurance or any other costs, charges expenses and outgoings of and incidental to the management, administration and maintenance of the Trust herein contained including the wages and salaries of employees;
- (b) After payment of outgoings and other expenses as aforesaid the trustees shall pay and apply the balance of interest, dividends, rents,

profits and other income (hereinafter referred to as "the net income") of the Trust Property and if necessary the corpus or any part thereof for all or any of the following charitable objects and purposes:

- (i) To promote and propagate Hindu religion and culture;
- (ii) To manage, maintain, run and conduct Shri Pranami Balika Sewa Asharama, Dugra Baste, Kalimpong, (West Bengal), founded by the Settlor;
- (iii) To manage, maintain, run and conduct Shri Pramnathji Brahmacharya Ashrama with Sanskrit Pathshala at village Haidarpara, Suliguri, (West Bengal), founded by the Settlor;
- (iv) To frame rules and regulations for the proper management and maintenance of the two Institutions mentioned in sub-clauses (ii) and (iii) hereinaabove and to add to alter, modify or delete rules and regulations.
- (v) To conduct and/or manage and/or aid the conduct of schools, colleges, libraries, hostels, research centres and any other educational institutions with or without fees as the Trustees may from time to time in their descretion determine;
- (vi) To give scholarship and other assistances to any student prosecuting studies either primary, secondary technical, diploma, under-graduate college or post-graduate in India or abroad;
- (vii) To help societies and institutions which have similar objects by way of grants, donations or otherwise;
- (viii) To promote and propagate the study of philosophy, sociology, culture and religion and any branch of

- (ix) To carry on and conduct all activities for the upliftment of the humanity and to do all acts and things for the achievement of the said object;
- (x) To donate the net income of the Trust property or any part thereof to any institution which is likely to promote education or any other objects of public general utility;
- (c) The Trustees shall be at liberty to utilise the corpus of the Trust property or any part thereof for any one or more of the objects aforesaid and in such proportion as they may in their absolute discretion think fit;
- (d) The Trustees shall be at liberty to donate any part of the Trust property to any institution carrying out any one or more of the aforesaid objects on such terms and conditions as the Trustees think fit;
- (e) The Trustees shall be at liberty to use any part of the income or corpus of the Trust property for the purposes aforesaid either directly or through schools or any other institutions carrying out the aforesaid objects.

5. The Trustees for the time being of these presents shall be at liberty to keep the Trust property in its present state of investment or in the state in which it is donated and subject thereto the Trustees shall invest moneys belonging to the Trust property or all additions or accretions which may be

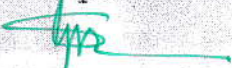

made and all surplus moneys liable to be invested after meeting the necessary expenses of the Trust in or upon any stock or security or investment authorised by law or specified in Section 20 of the Indian Trust Act III of 1882 or in the purchase of or on the mortgage (equitable or legal) of immovable property or properties of any tenure as the Trustees at their discretion select with power for the Trustees subject to such discretions aforesaid to vary or transpose the said investments into or for others of the nature hereinbefore authorised and sell and/or realise any of the securities, investments or immovable property forming part of the Trust property, invest the amounts so received by them in investments in securities or immovable properties as hereinbefore authorised and shall hold the same respectively and investments for the being representing the same and the rents, dividends, interest and income thereof upon the same user trusts and powers and provisions as are hereinbefore declared and contained of and concerning the trust property.

6. It is hereby agreed and declared that if the Trustee hereby constituted or any of them or any Trustee or Trustees hereinafter appointed shall die or shall desire to retire from or be discharged or refuse or become unfit or incapable to act in the trusts of these presents subjects as hereinafter provided it shall be lawful for the continuing Trustees or Trustee for the time being of these presents (and for this purpose every refusing or retiring trustee shall if willing to act in the execution of these power be considered as a continuing ~~trustee~~ trustee) and if there shall be no continuing trustee then for the executor or executors, administrator or administrators of the last continuing or surviving trustee to appoint any other person or persons to trustee or trustees in the place of the

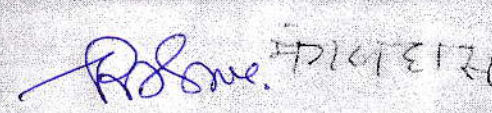
9.. The Trustees shall not be responsible for involuntary losses caused to the Trust property by reason of transfer of investments or re-investments of the securities under the power hereinbefore contained unless the same is done by any wilful act or default of the Trustees or any one or more of them in which event the defaulting Trustee or Trustees shall be liable for such act or default.

10.. The Trustees shall get the accounts of the Trust audited by a Chartered Accountant or a firm of Chartered Accountants once every year. Accounting year of the Trust shall be Financial Year.

11.. The Trustees shall have power to let or demise any property of the Trust or any part thereof or sell or dispose of the same or any part thereof either with public auction or private treaty and on such terms and conditions as they may deem fit and to execute the necessary deeds and documents and effectual receipts for the sale proceeds to purchase new property out of the income and/or sale proceeds of the Trust property or any part thereof or from the corpus of the Trust Fund for the purpose of erecting new building or invest the same in one or more investments and vary and transpose the investments for the time being, provided that the investments shall be such as are hereby authosised.

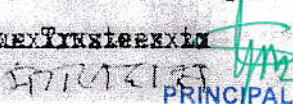
12. The Settlor constitute a Committee consisting of himself and six other persons :-

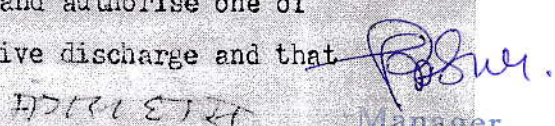

13.. The said Committee shall be known as GURUJI PRANAMI MISSION TRUST COMMITTEE . The said Committee shall have power to collect funds and donations and offerings for and on behalf of the trust. In the event of any donations or contributions being earmarked for any of the particular purposes of the Trust as may be considered admissible , the Committee shall accept such donations and contributions and intimate the specific directions of the donor so that it may be properly honoured. Except such donations for any specific purposes all other collections shall be invested by the Trustees in such manner as they deem fit and proper. The said Committee shall be competent to frame rules and regulations for the conduct of the business.

14.. AND IT IS HEREBY AGREED AND DECLARE that it shall be lawful for the Trustees at their discretion to accept from time to time from any person or persons or anybody or bodies corporate or incorporate any donations moneys property moveable or immovable upon such terms and conditions as may be agreed upon by the Trustees and may be considered admissible provided that the terms upon which such donations contributions shall be accepted shall not in any way be inconsistent with or repugnant to the objects of the trust and the Trustees shall hold such donations or contributions upon the terms as may have been agreed upon and approved as aforesaid and utilise the corpus or income thereof and authorise one of the Trustees to pass receipt and to give discharge and that

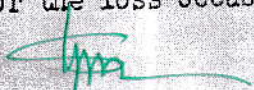
the Trustees if necessary shall execute such Trust Deeds or other writings or instruments in respect thereof as they may from time to time approve of and direct in respect of all such donations and for the purpose of collection of such donations formulate schemes instal charity collection boxes and adopt such other means as they think fit.

15.. During the lifetime of the Settlor in case of any difference of opinion among the Trustees or the members of the Pranami Mission Trust Committee with regard to the execution or application of the trust or power herein contained or with regard to anything to be done or omitted to be done in relation thereof the decision of the Settlor shall be final and binding upon the Trustees and/or the said Committee. After the samadhi (demise) of the Settlor the decision of the majority of the Trustees or the majority of the members of the said Committee shall be binding.

16.. AND IT IS HEREBY FURTHER AGREED AND DECLARED that the Trustees may reimburse themselves or pay and discharge out of the Trust property all expenses incurred in or about the execution of the trusts and powers of these presents.

17.. The Trustees shall be at liberty to maintain a Reserve Fund and such Reserve Fund shall be invested in the manner hereinabove provided.

18.. The Trustees shall have full power to settle out of Court or compound all suits actions and other proceedings and all differences and demands and to refer any or all of such differences or demands to arbitration and to adjust settle and approve all accounts relating to the Trust property and to execute release and to do all other acts and things relating thereto as if they were absolutely entitled to the Trust property and without being answerable for the loss occasioned thereby.
